Along with Dean Rempson and Dr. Donna Genova, he attended the CUNY Basketball Tournament Luncheon. Dr. Corbie invited the new Comptroller, Alan Hevesi, to visit the college.

THE CHAIR

1. Documents were distributed.

DEAN CANCIENNE

1. The annual request to the Bronx Borough President, Fernando Ferrer, has been submitted to the Central Office for approval. A total of \$510,000 has been requested.

GOVERNANCE PLAN. Dr. R. Bass announced the votes on the proposed amendments to the Governance Plan. (see attached amendments)

Faculty: 93 FOR; 8 AGAINST

AMENDMENT IV: Functions of Senate - Revision  
Students: 535 FOR; 33 AGAINST  
Faculty: 88 FOR; 14 AGAINST

MASTER PLAN UPDATE: Dean Cancienne reported on the status of the work toward the Master Plan.

SPECIAL PROGRAM PRESENTATION: Ms. Winifred Washington, Coordinator of the B. C. C. Family College spoke about the program. The Family College is funded by the HRA, CUNY and the Board Of Education and is designed to enable students with young children to complete their associate degrees.

#### COMMITTEE REPORTS.

CURRICULUM. Dr. J. Ryan presented one item for action by the College Senate.

ACTION: By voice vote, the senate voted to consider the actions taken by the Curriculum Committee on February 22, 1994.

ACTION: By voice vote, the senate approved the following action by the Curriculum Committee.

To change the names of BIO 46 and BIO 47 from Clinical Technology for Medical Secretaries to Clinical Technology for Medical Personnel I and II.

GOVERNANCE. Dr. R. Bass announced the results of the election for University Faculty Senate. Dr. M. Cummins will serve a three-year term. Profs. K. Fogarty and A. Glass will serve one-year terms as alternates. In addition, Dean J. Rempson had asked for a ruling of the procedures in the SGA Constitution regarding the impeachment of a Senator. It was advised that decisions could be made by 2/3 of the students in office. It was suggested that all petitions requesting SGA action must have the resolution stated on the same page as the signatures.

INSTRUCTION. Prof. A. Pomerantz reported that the committee would meet on March 10 in GSC 208, and reminded members that each division was to elect 2 members to the committee.


UFSS. Dr. A. Galub reported on the budget for the Community Colleges.
