1. **Call to Order:** 12:31 P.M., A. McInerney
2. **Greetings:** A. McInerney wished everyone a Happy New Year and welcomed the guests to Senate. A. McInerney noted the recent weather and thanked the grounds-people of BCC for their good work in clearing the snow. The following changes have occurred in the Senate membership: D. Gonsher will be replacing I. Mirsky who is on leave; C. Aleong (HPEW representative) will be replaced by D. Genova; J. Wilson is now the acting chair of Education and will be replaced; J. Cabrera is a new student senator. D. Read and P. Read have retired and their seats are vacant. There are 5 vacancies in the SGA ranks.

6. **Election of Ombudsperson for Spring 2011: V. Bonelli is retiring and cannot continue in this role.** A motion was made to continue this process at the March meeting. A. McInerney noted that the position ends at the May meeting.

7. **President’s Report:** A. McInerney conveyed C. Williams’ reminder of Convocation tomorrow, February 4, 2011.

8. **Announcements and Reports**

a. **Chairperson, Vice-Chairperson, and Faculty Council Chairperson**

- i. A. McInerney announced the appointment of Dr. Carole Berrotte-Joseph as the next president of Bronx Community College. Her official start date is July 17, 2011. A. McInerney thanked the body for their active participation and engagement in the search process. He would like to ask the body to extend a welcome to Dr. Berrotte-Joseph.
  - 1. D. Gonsher made a motion for the faculty to meet at 10 AM on February 14<sup>th</sup> to discuss this transition. [The Chancellor will be making a visit to BCC at 10 AM on 2/14/11 and select invitations to this meeting will be issued.] Motion approved unanimously with 2 abstentions (A. Cancetty, G. Sanchez).
- ii. D. Peters called attention on the changes that have been made at the College and University. In particular, the tuition hikes of particular concern. D. Peters and 5 other students have filed a lawsuit about the tuition hikes (see attached flyer). If you do support the lawsuit, please show up in the courtroom on February 22, 2011 at 9 AM and encourage your students to show up as well.

- iii. H. Skinner (acting faculty council chairperson) called attention to the February 10, 2011 faculty council meeting (see attached agenda and meeting dates).

**b. Vice-Presidents and Deans**

- i. G. Sanchez noted that questions about the topics being discussed in committee should be addressed to the committee chairs in a timely manner. Convocation is tomorrow, February 4, 2011. Many people have retired (Business: Assoc. Prof. Doreen LeBlanc, Prof. John Morales, Asst. Prof. Don Read, Prof. Jacinto Suarez, Assoc. Prof. Henry Weiman; Chemistry: Assoc. Prof. Sydney Alozie; Education & Reading: Prof. Howard Irby; English: Lecturer Mark Chaffie, Dist. Prof. John Hall, Assoc. Prof. Phyllis Read; HPEW: Prof. Michele Stern; History: Prof. Vincent Bonelli; Mathematics & Computer Sciences: Prof. Susan Forman, Prof. Henry Frisz; Modern Languages: Asst. Prof. Lydia Gorycki; Nursing: Prof. Lois Augustus, Asst. Prof. Ingrid Mueller, Assoc. Prof. Marva Watford; Physics: Asst. Prof. Samir Saddawi) and there is a plan at the Chancellery to replenish the professorial ranks. Dr. Joan Wilson is the new acting chair of Education and Reading. New faculty hires include Jonathan Katz (English- Lecturer as of Fall 2010), Amerigo Rossuello (HPEW – Instructor), Nicole Saint-Lewis (Social Sciences & New Community College -Assistant Professor). There is still a hiring freeze for all other staff. Sanchez congratulated the Presidential Grant Awardees: Barbara Schaeir-Peleg, Andrew Rowan and Melissa Kirk, Claudio Mazzatenta, Suzan Moss and Donna Genova, Susan Amper, Robert Maryks, Sunil Bhaskaran, Nikolas Anuku, and Harriet Shenkman. G. Sanchez called attention to the activities of the Office of Instructional Technology (<http://www.bcc.cuny.edu/InstructionalTechnology/>) and the Center for Teaching Excellence (<http://www.bcc.cuny.edu/CenterForTeaching/>).

- iii. P. Barbatis announced 11,108 enrolled students, which is short of the goal of 11,330. He would like to thank everyone who has helped with enrollment. Student Affairs developed a fact-book and accomplishment report (which is available online at <http://www.bcc.cuny.edu/announcements/documents/factbook.pdf>). They will be transferring to the new building next to Colston. The ribbon-cutting is April 15<sup>th</sup>. They are looking into student interventions. There is a behavioral intervention team (BIT) on campus, which has 6 members and is meeting biweekly to develop their rules and regulations and their processes. Next week they are sending out electronic copies of the student referral form for student behavior.

## RALLY OUTSIDE THE NEXT CUNY HEARING!

**S**ince 1990, CUNY's state appropriation has declined by \$492 million with an extra 9.5 million for this year alone.

Mayor Michael Bloomberg has cut CUNY's city aid by more than over a \$100 million dollars in cuts to all the CUNY Community Colleges since 2004. Now the mayor has another 32 million proposed in cuts.

Chancellor Matthew Goldstein will get an extra \$40,000 this year, bumping his overall compensation to \$580,000. The 9% salary increase comes atop a 14% increase in November 2008.

Since 2006 tuition in CUNY has risen 44% since 2006 and 276% since 1990.

In December 2010, the Board of Trustees approved a series of tuition increases that will shift the burden of

paying for higher education on the ones that can afford it the least—poor and working class students..

Chancellor Goldstein and the CUNY trustees are turning their backs on the mission of open admissions, where any one that has a GED or High School Diploma will be admitted to CUNY.

Mayor Bloomberg and Governor Cuomo are slashing funds to CUNY as part of their program to put the burden of the economic crisis on poor and working people.

### It's time to fight back!

Six student leaders are suing Chancellor Goldstein and the trustees for their effort to sneak around state law in order to raise our tuition. It's just one step in building the movement to keep CUNY as a resource for working class communities.
