<p>Section AIV: New Courses AIV.1: English Department Course Number: AA Title: Afro-Caribbean Literature Recitation: 3 Lab: 0 Credits: 3 Prerequisites: ENG 1011</p> <p>Course Description: Introduction to prominent writers from Africa and the Caribbean. Representative literary works are read and analyzed. Critical writings, including a research paper, are required.</p> <p>Rationale: This course will make an important contribution to the BCC English Department's efforts to offer a broader range of elective courses that better represent the College's commitment to developing our students' global awareness. Afro-Caribbean literature is an important body of literature, but also exposes them to a vital cultural conversation. Since most literature courses offered by the English Department focus on North American and Western European literary traditions, offering this course on a regular basis will remedy an existing imbalance. Finally, the subject matter of the course mirrors the demographic make-up of students at BCC, thereby giving them the opportunity to look into their culture and traditions through some of the most accomplished writers from the regions. This course would be applicable, either as a required additional English course or as an elective, in the following curricula. Both primary literary works by women and theory about women's literature are read and analyzed. Critical writings, including a research paper, are required.</p> <p>Rationale: This course will make an important contribution to the BCC English Department's efforts to offer a broader range of elective courses that better represent the College's commitment to developing our students' global awareness. The intellectual history and theory of women's literature is an important body of literature, but also exposes them to a vital cultural conversation. Since most literature courses offered by the English Department continue to play in literary life. Currently, there is no course offered in women's literature at BCC, even though the majority of literature programs at community colleges both in the CUNY system and outside it have such a course. Therefore, this class will remedy a major gap in our English program and at the College in general. By adding this course, BCC sends a clear message about the topic's importance to the College community. This course would be applicable, either as a required additional English course or as an elective, in the following curricula. <p>Section AIV: New Courses AIV.1: English Department Course Number: CC Title: Introduction to Creative Writing Recitation: 3 Lab: 0 Credits: 3 Prerequisites: ENG 1011</p> <p>Course Description: Introduction to the forms, techniques, and approaches to writing in the creative genres, including fiction, poetry, drama, and creative nonfiction. Readings, daily writing assignments, and revision of written work are required. Students will produce a portfolio containing a series of creative writings in various genres, as well as one piece of critical writing with research.</p> <p>Rationale: This course will make an important contribution to the BCC English Department's offerings. Though the English Department course in creative writing has been offered since 1997, it has not been a high priority. The Creative Writing Club, however, offers great interest among our student body in exploring the creative side of writing. This course will thus fill a gap in the curriculum and offer students another route to fulfilling their English elective requirement in a reading and writing intensive environment. This course would be applicable, either as a required additional English course or as an elective, in the following curricula. Representative literary works from Mexican-American, Dominican-American, Cuban-American, Puerto Rican and other Latino writers are read and analyzed. Critical writings, including a research paper, are required.</p> <p>Rationale: This course will make an important contribution to the BCC English Department's efforts to offer a broader range of elective courses that better represent the College's commitment to developing our students' global awareness. The intellectual history and theory of Latin-American literatures, and we believe that it is important to represent their cultures through the literatures taught in our department. Currently, there is no course offered in Latino/Hispanic literature at BCC, even though such course offerings are the norm in English departments around the country. This course thus meets a fairly pressing need in updating our curriculum for the twenty-first century. This course would be applicable, either as a required additional English course or as an elective, in the following curricula.
